## **REOPENING OF THE BASQUE CENTER**

In March of 2020, the Euzkaldunak Board and Basque Foundation had to make difficult decisions and take action to keep our community safe as this crisis unfolded.

Since then, we have been closely monitoring local, state, and national health guidelines and regulations regarding COVID-19; we continue to act with our members' and the larger community's safety in mind.

The Board of Directors is pleased to announce the reopening of the Basque Center Bar and Cardroom on [Thursday, May 6, 2021](#).

The following restrictions will be in place:

- Initially open only from Thursday to Sunday, 2:00 to 10:00 PM
- Face coverings that completely cover the nose and mouth while indoors are required
- Seating will be limited to 50% of capacity
- The CDC's social distancing guidelines of 6ft or more will be in place

As always, the board will continue to monitor the situation and make appropriate decisions on increasing or decreasing hours of operation.

## **2021 NABO UDALEKU POSTPONED**

NABO's Udaleku 2021 in Bakersfield, California has been postponed until summer 2022. NABO organizers are aware that a number of youths have missed one or two years of Udaleku eligibility and therefore are considering ways to accommodate those students in 2022. Some ideas include expanding the age range for Udaleku (usually age 10-15) or a special Udaleku just for those affected by the COVID-19 cancellations of Udaleku 2020 and 2021. ## Basque Center History Corner: the current state of the facility

The monthly "history corner" column is written by members of the Basque Center Renovation Committee, a cross-section of Euzkaldunak members who meet every other month with the express purpose of creating a path forward to a renovated Basque Center. This month's "history corner" will focus not so much on the past but on the present-day conditions of the Basque Center.

We know how important the Center has been to the countless generations of Boise Basques before us, and our unique gathering space is an important part of how we practice our "Basqueness." The purpose of a renovation plan is to ensure that the Basque Center remains a vibrant, modernized place for Euzkaldunak members in many generations to come. This isn't the first committee that has been formed to investigate renovation, and we're using the findings of previous investigations to guide our way forward.

The Renovation Committee has been meeting periodically since the beginning of 2020, and part of our investigation has been a current inventory of repairs that the Basque Center building desperately needs. These must-fix issues include (grouped by area of building):

### Basement

- Non-ADA compliant bathrooms
- Old finishes, peeling paint, and falling ceiling tiles
- Dim lighting
- Insufficient storage for tables, chairs and other equipment
- Insufficient daylighting (single-pane windows)
- Low level of accessibility from main hall
- Limited external (outside) access
- Sump pump issues
- sub-par heating/cooling

## History Corner (cont'd)

### Basement Kitchen

- Old equipment and appliances
- Crowded layout of refrigerators
- Lack of storage and work surfaces
- Exhaust fan not up to current building/safety code
- Improper heating/cooling
- Old lighting fixtures
- Plumbing issues

### Main Hall

- Old finishes on walls, floors and ceiling
- Old lighting fixtures
- Severe lack of storage for tables, chairs and other equipment
- Insufficient daylighting (single-pane windows)
- Outdated and complex A/V system
- Outdated heating/cooling

### Bar

- Bathrooms are not ADA compliant or accessible
- Old finishes on walls, floors and ceiling
- Dim, outdated lighting
- Lack of storage
- No daylighting
- Congested traffic flow through to main hall
- Congested traffic flow up to card room

### Exterior

- Sub-optimal accessibility to/from Bar
- Sub-optimal accessibility to/from Main Hall

**The unfortunate thing is, this list of must-do items above is just the bare minimum needed to keep the Center hobbling along in its current state.**

If we made these improvements and nothing else, it would help keep the facility condition from worsening. But it wouldn't solve the root problem: the Basque Center is a very old building, and aside from adding an elevator and remodeling the bar and

restrooms, not much has been done construction-wise on the interior since the 1950s.

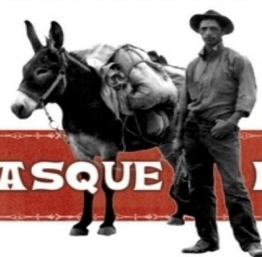

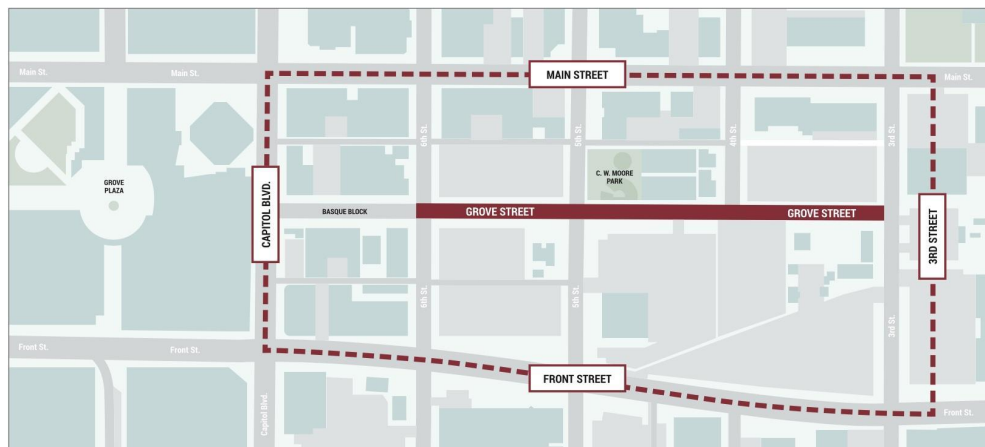

## **CITYSCAPE AROUND THE BASQUE CENTER**

Over the last year due to the COVID-19 pandemic, people's traditional social activity waxed and waned, especially due to lockdowns or other mitigations. Regardless, many construction projects close to the Basque Center have continued despite the pandemic. If you are one of the people who have stayed away from downtown Boise and Basque Block, here is a list of projects that will impact the cityscape that you'll see when you return to the Basque Center.



### ***Grove St / Old Boise Blocks Streetscape***

The Old Boise Blocks on Grove Street consists of eight city blocks along the east end of Grove St., adjacent to Boise's downtown core. The project area includes properties on the east side of 3rd Street to Capitol Boulevard and is bounded by Main & Front Streets on the north and south.

Within this project area, particular focus is given to Grove Street itself between 3rd & 5th Streets and the properties immediately adjacent to the street.

The history of Boise's Grove Street tells us a great deal about the history of the city itself. Grove Street was one of the originally platted streets on the city's first plat in 1864. Historic Sanborn Fire Insurance maps show that the street's original alignment was slightly to the north of the current street between 4th & 10th. The city widened Grove Street three times before 1903 and has since extended it west to 16th Street.

Historical records illustrate significant trends in urban development along its length, from a mixed-use residential area with lush tree groves to a commercial neighborhood dominated by the automobile industry in the mid-20th century. Today, the street is home again to residents and is beginning its return to a dense, mixed-use corridor. In examining the history of Grove Street, five themes emerge that help describe the street's history as well as the history of the city overall: Mixed Use, Irrigation, Transportation, Industry and Neighborhood.



### **512 W Grove St**

Mixed-use 3 story office/mercantile building at 113 S 5th St. Project is under same ownership as 5th & Grove and 6th & Grove projects currently under construction and will serve 2 small professional offices and a ground floor mercantile tenant.



### **4<sup>th</sup> & Idaho St**

Mixed-use 13-story tower at the corner of 4th St. & Idaho St will include 100 apartments, 5 floors of parking with 420 spaces, and 6,000 square feet for retail or a restaurant on the first floor.



### **270 E Myrtle St**

7-story, mixed-use building at 270 East Myrtle St will include 243 apartments, plus parking and 1<sup>st</sup> floor retail space.

### **116 S 6<sup>th</sup> St**

The Lucy / Thomas Logan Apartments is a multi-family housing, office and retail space project at 116 S 6th St. This will be two separate projects under common ownership. A 7-story building at 6th & Grove will feature 50 apartment units, with the majority provided to residents making 60% of average median income and below. The building will also include office space and ground-floor retail. A separate 6-story building at 5th & Grove is also being built and will include 114 apartments, as well as ground-floor retail. The two projects will be linked by an urban courtyard.



### **323 W Broad St**

Mixed-use 7-story building at 323 W Broad. The Hearth (formerly The Cartee) will include apartments, parking and 1<sup>st</sup> floor retail space.



### **600 W Front St**

Currently under construction is The Vanguard, an 8-story, mixed-use building at 600 W Front St to include 72 residential units, 1<sup>st</sup> floor retail and bicycle parking.



### **Block between Grove, Front, 3rd & 5th Streets**

The Ada County Board of Commissioners met with the Capital City Development Corporation to discuss redeveloping the block bordered by Grove and Front to the south and north, and 3rd and 5th to the east and west. It's currently unknown what kind of development could come to the area, but CCDC is considering commercial office space, retail, housing, and an additional public parking garage.

A triangle-shaped lot owned by Ada County, currently used for parking, takes up a large portion of the area. It also contains the CW Moore building, a multi-story office building with Zee's Rooftop Cafe on the roof, as well as parking lots surrounding the tower, a gravel lot and a small, older apartment complex.



### **200 W Myrtle St**

A mixed-use 7-story building at 200 W Myrtle St., Boise Caddis will contain 173 apartments and 400 parking spaces (Ada County plans to purchase the parking garage from developer) for general use, retail & commercial space.
